If you have other family members on the <u>plan</u> , each family member must meet their own individual <u>deductible</u> until the total amount of <u>deductible</u> expenses paid by all family members meets the overall family <u>deductible</u> . |
| Are there services covered before you meet your <u>deductible</u> ? | Yes. <u>Preventive care</u> and pre- and post-natal care. | This <u>plan</u> covers some items and services even if you haven't yet met the <u>deductible</u> amount. Does this plan provide Minimum Essential Coverage? Yes.
